Minutes for 10.14.20 approved

We need the student activities deans (Leticia and Michelle) to get on the same page regarding the student rights and responsibilities BP and APs.

Academic integrity concerns are coming up at Foothill. Concern that policies and procedures aren't being interpreted the same way/followed. Leticia mentioned she'd reach out to Michelle. Will discuss at next meeting whether we need to bring this to APM.

Mention that number one on AP 4235 (pg 2), needs wording change to reflect "credit for prior learning."

Kathryn would like for discussions to happen about CPL at a task force, before we have discussions at the senate or college curriculum committee. Request to have a select group of folks look at the current proposed AP 4235. Have a look through this AP, can you all live with what this says? Karen- similar to how we're getting Michelle and Leticia info, and asking for feedback for the Student Rights and Responsibilities policies. Isaac will email folks related to CPL work, and see how they feel about the strategy of first considering approval of title 5 compliant language, while simultaneously planning more in-depth discussions.

Is APM the place to have discussions about reopening the campuses? Have this on the next APM to talk about where this should be talked about. Invite Chancellor Miner to be a part of the discussion.

Minutes for 10.21.20 DAS Meeting
